

GÖRG advises Trianel Erneuerbare Energien on the acquisition of the Spreeau wind park

GÖRG advises Trianel Erneuerbare Energien GmbH & Co. KG (TEE) on the acquisition of the Spreeau wind park in Brandenburg. The seller of the wind park is ABO Wind AG from Wiesbaden, which will also be responsible for the construction of the wind park. With eight Vestas V150-4.2MW wind turbines and a total output of 33.6 megawatts, the Spreeau wind park is the largest in TEE's portfolio to date.

The wind park is scheduled to be operational by the end of 2021. In future, it will produce around 110 million kilowatt hours per year - this corresponds to the consumption of around 33,000 households and saves around 75,000 tonnes of carbon dioxide annually. TEE, which already operates a wind park in the immediate vicinity of the Spreeau wind park, and ABO Wind AG had already cooperated during the project planning of the wind park.

Under the lead management of partner Jan Schellenberger, GÖRG structured the purchase process for TEE, accompanied the negotiations and provided comprehensive advice on all legal issues within the transaction as well as in the context of the cooperation.
