The financing is intended to help strengthen product development for AI-supported histopathological examinations and to further expand the commercialisation of the technologies in several regions.

MindPeak GmbH, founded in 2018, develops state-of-the-art algorithms that support pathologists in routine diagnostics, with a focus on automating tissue analysis for faster and more accurate results.
